Around 40 iwi members attended the Wānanga Ahurea held at Ūkaipō recently. The wānanga was facilitated by Jeremy MacLeod and Awhina Twomey and included a day trip to Meretoto (Ship Cove, Queen Charlotte Sound). We would like to thank Judith MacDonald for coming along and sharing kōrero with whānau about the area and its significance to Rangitāne. A pōwhiri will be held at Meretoto in November as part of the Tuia 250 commemorations.

# **KURA REO FIRST FOR TE TAU IHU**

Rangitāne o Wairau held its first Kura Reo in July with over 70 attendees. This is the first Kura Reo of this nature in Te Tau Ihu and was held at both Ūkaipō and Tuamātene.

There were two levels of ability, Te Tūāpapa, facilitated by Te Ataarangi and Te Kura Whakapakari, supported by Jeremy MacLeod and Te Korou Whangataua. The Kura Reo was held over five days, attracting many of our local whānau, as well as iwi members from outside of the rohe, some whom had never visited Wairau before. The week was hugely successful, including a trivia night as well as regular waiata and haka sessions. The week ended with students performing E mihi atu nei, followed by our haka Rangitāne, upoko ki runga! Performed as a ngeri.

Kura Reo is an initative started by language guru, Sir Tīmoti Kāretu at Waimārama Marae, Hawkes Bay in 1989. Since then, Kura Reo has grown exponentially. There are Kura Reo held across the nation in Ngāti Kahungunu, Te Whakatōhea, Ngāti Hauā, Te Taitokerau, Rotorua, Otaki, Tokoroa and Otautahi. Rangitāne o Wairau is thrilled to announce the plan to hold this event annually in the first week of the July school holidays.

Te Tūāpapa, supported by the Te Ataarangi ki Te Tau Ihu consisted of four levels. The Te Ataarangi ethos is humility, and we were very fortunate to have the tutors that epitomised this principle. Te Ataarangi is renowned for providing a very supportive and conducive learning environment

In the Kura Whakapakari, students learned idioms, informal language, contemporary idioms, and also examined the writings of Rangitane tūpuna Teoti Makitanara and his son Tuiti.

We wish to thank those who attended this inaugural Kura Reo and look forward to cementing this as an annual event. Tangata Rau, Reo Kotahi, kia mau!

# **NEW TENANTS AT RANGITĀNE HOUSE**

Following recent news that the Blenheim Police Station requires structural repairs, Rangitāne Investments have been working closely with Ngā Pirihimana o Aotearoa (New Zealand Police) to support them in their search for temporary office space.

We are thrilled to advise that Ngā Pirihimana are now tenants on Level 1 of Rangitāne House. The previously vacant space on Level 1 has been fitted out to a high standard and will provide Rangitāne with improved returns on the property.

We are continuing to work proactively with Ngā Pirihimana, to support them as they work through the issues with the Police Station.



# COMMERCIAL PROPERTY MANAGER APPOINTED

After a recruitment process earlier this year, Rangitāne Investments have appointed Corey Hebberd as Kaiwhakahaere Rawa Tauhokohoko – Commercial Property Manager.

Corey comes to us from a role at Marlborough Lines in the team supporting property, procurement and fleet management. He is Rangitāne and descends from George Hori Toki MacDonald through his through his great-grandfather Manaia (Nugget) MacDonald.

Corey takes over the role from APL Property, who we would like to convey our sincere appreciation to for the work they have done in managing our properties to date and who have supported us since Settlement.

Since commencing, Corey has made a number of positive achievements for the Group, including securing New Zealand Police as a tenant in Rangitane House and achieving a significant reduction in the Group's insurance premium.

## NEGOTIATIONS CONTINUE

We are continuing to negotiate with NZDF over the acquisition of RNZAF Base Woodbourne.

To date, we have secured ownership with other Kurahaupō iwi on the former Golf Course Property and are currently negotiating Stage 2, the Housing Estate.

We will continue to update members as these negotiations progress.

# MILFORD APPOINTED TO MANAGE FUNDS

Since Settlement, the Group has consistently held a significant amount of cash on its balance sheet available for investment. As at 31 March 2019, the Group held \$13.8m of cash assets.

After a selection process, the Group has appointed Milford Asset Management to provide managed fund services, with an initial investment of \$5m.

With interest rates currently sitting around 3%, the Milford opportunity provides another means of diversification to our balance sheet and allows us to achieve better returns in the medium term on our asset base.

# STAGE ONE NEARS COMPLETION

Things are really humming down at our development in Horton Street. The new, purpose-built Marine & Outdoors building has been completed.

This exciting new development by Rangitāne Investments will be a catalyst to further development in the area.

A dawn blessing will take place at the opening of the new building.



# RANGITĀNE INVESTMENTS SECURES OWNERSHIP OF FLAXMILL VINEYARD

Rangitāne Investments is pleased to announce the successful acquisition of the Flaxmill Vineyard located at Rārangi.

Following a period of extensive due diligence to ensure that the investment met the requirements of our Statement of Investment Policy Objectives (which requires a rate of return exceeding 7%), we have now completed the purchase process at a very competitive price, and look forward to the fruits of the vineyard's success.

Our investment philosophy includes the need to achieve strong cash returns, seek opportunities to grow our capital value and add value for the benefit of Rangitāne going forward. The vineyard is part of Sustainable Wine Growing New Zealand and has been purchased with an existing Grape Supply Agreement with Matua.

Rangitāne joins iwi such as Ngāi Tahu and Ngāti Rārua who have also invested in vineyard properties. This investment supports the continuing diversification of our balance sheet, alongside active investments such as the Marine and Watercraft development on our Horton Street property in Blenheim.

We look forward to seeing the benefits of this acquisition flow through, supporting the strategic priorities of Rangitane into the future.
