1. OPENING KARAKIA/MIHIMIHI:

The AGM began with a tribute to members who have passed away during the past year. Te Matahiapo (Safari) Hynes opened the hui with karakia, which was followed by waiata.

The Trustees introduced themselves to meeting attendees and Corey Hebberd introduced kaimahi, Directors and Advisors in attendance. He addressed health and safety, and general housekeeping and Trust Co-Chairperson Calvin Hart outlined the purpose and kaupapa of the AGM.

The Co-Chairpersons presented Uncle Lawrence MacDonald with a taonga to acknowledge his contribution to the iwi and wider community. This taonga reflected Uncle Lawrence's enduring service and dedication to Rangitāne, reflecting his constant presence, and the giving of his time, energy, and aroha to support whānau and the wider community. The Co-Chairs highlighted that Uncle Lawrence represents Rangitāne at Ōtamawaho urupā, leads ANZAC commemorations with pride, and is a key figure in dawn blessings, pōhiri, and wānanga. He also represents the iwi on the 28th Māori Battalion Committee and the Springlands Streams Governance Group, as well as tending to the graves of tīpuna across the rohe. They also acknowledged him as a former Trustee of the Trust, and Chair of the Incorporated Society.

5. ANNUAL REPORT FOR THE YEAR ENDING 30 JUNE 2024

The Annual Report for the year ending 30 June 2024 was tabled and taken as read. The Annual Report included:

Financial Management

The General Manager introduced the Audit, Risk and Compliance Committee (ARCC) and spoke on behalf of the Chair Johnte McFadyen-McDonald. The purpose of the ARCC is to govern the audit function, financial reporting function, the risk assessment, response and compliance performance of the functions, and assets of the Rangitāne o Wairau Group.

The ARCC and General Manager work together to regularly review financial policies, procedures and external providers. During the year, the ARCC supported a comprehensive review of the Group's insurance programme, which led to a change in insurance broker from Aon in Christchurch to Gallagher (formerly Crombie Lockwood), who are based in Rangitāne House. This transition also enabled the Group to undertake a review of risk management practices.

The General Manager spoke to the asset growth since Settlement noting that overall growth has been modest in recent years due to inflationary pressures and the impact of downward pressures on property values.

The General Manager introduced Karen Draper from Wallace Diack as the accountants for the Group. Karen provided an overview of Wallace Diack services to the Group and an overview of the financial performance. Highlights included:

- The Group achieved an operating profit of \$1.6m, a net profit of \$1m and closing net assets (equity) of \$88.5m.
- Total Comprehensive Revenue and Expenses increased to \$1m (-\$1.3m last year).
- Property investments had revaluation impairment of -\$0.4m (-\$3.3m last year).
- Operating Surplus increased to \$1.6m (\$1.5m last year). It was noted that FY2024 and FY2023 were 12 month reporting periods whereas FY2022 was a 15 month reporting period.
- Distribution from RIL to the Trust of \$1.6m (\$1.5m last year).
- There was record investment in tribal activities for whānau with Programme Expenses rising to \$282k (\$257k last year).
- Total Assets for the year totaled \$93.38m (\$92.17m last year).
- Total Liabilities for the year totaled \$8.9m (\$4.7m last year).
- Loan changed to \$7.5m from \$2.5m the prior year.
- Investment properties impaired by a -\$0.4m revaluation (-\$3.3m last year).
- Total Group Equity increased by 1.1% to \$88.5m (\$87.5m last year).

Corey welcomed Cameron Town from Silks Audit (via Zoom) as the auditors for the Rangitāne o Wairau Group. Cameron spoke to the Audit process and noted highlights which included:

- Silks Audit have now been the Group's auditor for three financial years (ending 30 June 2022 through to 30 June 2024).
- After three years Silks Audit are building good processes with the Group and ARCC.
- Silks Audit undertake an audit of the financial statements of each entity as requested by the Trustees and Directors:
 - No specific additional audit work was undertaken
 - Audit opinions were issued on 8 November 2024
 - All the audit reports issued were unqualified. There were no critical findings for improvement in internal controls and no unadjusted difference.
- Auditors focused on the following significant areas:
 - Revenue recognition
 - Statement of Service Performance (Group)
 - Investment existence and valuation
 - Investment property valuation

Strategic Plan

Co-Chair Janis de Thierry introduced the strategic plan video which summarised the results of the strategic planning work which we started six years ago. The video explained what guided the Group's

operational and strategic decision making. The video also sets out the Group's planning objectives and provides the framework that we have reported on in the Annual Report.

It was noted that the Strategic Plan is set to be reviewed this year and there will be further engagement with whānau to seek their input.

Annual Report key highlights were addressed as follows:

Mana Motuhake (presented by Keelan Walker)

- Te Kotahi o Te Tauihu Charitable Trust has continued to support whānau in Te Tauihu. Jennie Smeaton (Ngāti Toa) and Corey Hebberd (Rangitāne) recently concluded their terms as Co-Chairs of the Trust, which is governed by the eight iwi Chief Executives. The Trust continues to adapt and flex with the changing and dynamic funding environment.
- Engaged in legal action in relation to Rangitāne's rights and interests on the East Coast of Te Waipounamu (successful High Court action in relation to two whale jawbones and awaiting outcome on the East Coast Beach Vehicle Bylaw case).
- Strengthened our relationship with Canterbury Museum, amidst their redevelopment project, with Otago University, and finalised partnership agreement with ngā iwi and ngā Kaunihera o Te Tauihu.
- Continuing to challenge and advocate political decisions that impact Rangitāne's rights and interests.
- The meeting watched a highlights video of work we have been doing with our Rangatahi titled "Sharing our Story by Rangitāne as Rangitāne". Keelan acknowledged those who have supported the capturing of this story, including the Ministry of Culture and Heritage.
- Trustees were asked to provide clarity as to where the whale jawbones will be held and how these will be allocated. Janis de Thierry noted that the whale jawbones were securely stored and that in regard to allocation, there has been no decision made, and management are currently working on a draft policy.
- Janis acknowledged Rangitāne o Wairau's submission to the Select Committee opposing the Treaty Principles Bill and noted that the General Manager will be presenting an oral submission at Parliament on Monday 27 January 2025.

Trustees were asked whether any action would be taken regarding the Māori Wards referendum. Janis noted that this is being considered at an iwi Chairs level and a plan will be put in place to mobilise our people to enrol to vote.

Mana Tangata (presented by Janis de Thierry)

- Acknowledged our Kaikōkiri:
 - Rangatahi: Sue McElhinney
 - Mātauranga: Peter Meihana
 - Hauora: Lauree Ashworth
 - Takahi Whenua: Rick & Rata Andrell
 - Toi Māori: Keelan Walker
- Also acknowledge were:
 - Mandy Dryer and Lisa Singh for providing support in the kaumātua space with our whānau in Horowhenua.
 - Taylah MacDonald and Skai Ingram (noting that Skai has now finished with Rangitāne but was with us for six months of the financial year) for their leadership in the delivery of Member Services.
 - Erina MacDonald and Phillipa Avery for their mahi in the Whānau Ora Navigator space. Also acknowledged Robbie McKinney for his work in this space prior to moving to his Kaitohu Taiao role.

- Key highlights within Mātauranga were a total of 369 tamariki supported through Poroiwi Education Grants and 41 scholarships provided to tauira in supporting education aspirations and achievement.
- Key highlights within Hauora were 53 successful Pūtea Tautoko grant applications and the developing Te Kāhui Hauora o Te Tauihu.
- Key highlights within Takahi Whenua were diving initiatives, kumara harvest and Maara kai upkeep at Tuamātene.

Mana Taiao (presented by Peter Meihana and Keelan Walker)

- Acknowledged Sally Neal and Robbie McKinney for their contributions to the Taiao space.
- Recognised representatives advocating for Rangitāne in environmental projects and governance groups.
- Blenheim Sewerage Treatment Plant: Ongoing work with MDC and Beca to ensure wastewater discharge solutions prioritise the health of the Wairau River. Whānau expect the plant to be relocated, with further engagement planned.
- Te Hoiere Restoration Project: Rangitāne is a key partner, contributing Mātauranga Māori to improve water quality and restore ecosystems.
- Resource Management Changes: Actively monitoring and engaging to ensure proposed law changes align with Treaty obligations and environmental priorities.
- Archaeological Monitoring Wānanga: Hosted to upskill whānau in protecting cultural sites, alongside RMA Commissioner training for Rangitāne members.
- Ohine-anau-mate Restoration: Leading efforts to restore biodiversity and cultural connections, working with local wine companies near the waterway.
- Wairau Wetlands Restoration: Collaborating with partners to restore wetlands, develop a cultural map, and establish a monitoring programme.
- Te Matapuna o te Wai Funding: Supporting capacity-building within the rohe, including Robbie's role and whānau upskilling.
- Te Pokohiwi o Kupe Protection: Engaged in preservation efforts, with research underway alongside NIWA and EQC, including whānau interviews on coastal impacts.
- Sustainable Customary Fisheries: Successfully entered the South Island Customary Fisheries Regulations, marking a major milestone after years of discussions.

A question from the floor asked whether Rangitāne intended to take a stand on the chlorination/fluorination of our water supply. The General Manager noted that a mandate made by Central Government directs the local council to fluorinate water supplies if directed by the Director General of Health. This direction has been issued however Rangitāne haven't taken a position on fluorination.

Mana Ahurea (presented by Wirihana de Thierry and Janis de Thierry)

- Acknowledged Kereana Norton, Paora Mackie, Te Matahiapo (Safari) Hynes, Wirihana de Thierry and Jeremy Tātere MacLeod.
- Cultural initiatives have continued to be delivered, consistent with the prior year, with strong whānau support. We acknowledge Te Matahiapo for his work in the delivery of paepae wānanga at Tuamātene Marae. The Trust also acknowledged Kereana Norton's significant contribution.
- Wānanga Ahurea continued across the motu with more whānau joining wananga including in Auckland. Planning is underway for these to take place in Auckland and Horowhenua this year.
- Kura Reo continues to be a success, empowering our whānau and providing useful tool and a basic level of fluency. A review is underway to assess the effectiveness of Kura Reo.
- Te Kaiaotanga o Te Reo Symposium in Wairau this year was a great success with key speakers inspiring our community and strong attendance across the rohe.

- We successfully repatriated koiwi to Te Pokohiwi o Kupe, that had been at Marlborough Museum.
- Rangitāne has supported important community initiatives like new whare (Council, Kainga Ora) and The Whale Trail.
- We delivered the region's largest Matariki event at Wairau Bar – this is a key whānau and community engagement event for Rangitāne.
- We've continued to invest in Marae upgrades and established our Whānau Ora services at the Marae.
- Janis de Thierry provided an update from Te Tauihu o Te Waka a Māui Māori Cultural Council on plans to host Te Matatini in 2027.
- Rangitāne Ahurei will be hosted in the Wairau over Labour weekend 2025. Further information will be circulated to whānau in the lead up to the event.
- The meeting watched a video showcasing the Matariki Wānanga for Rangatahi.

Mana Tahua RHL/RIL (presented by Leigh MacDonald)

- Leigh acknowledged the RHL/RIL Directors, advisors at Koau Capital Partners, the General Manager and the Property & Projects Manager.
- RHL/RIL reported a \$2.9m operating profit (3.3% return), with total assets increasing to ~\$90m (up from ~\$85m in FY23).
- Key investments included Hāpai Commercial (\$0.8m), Hāpai Housing (\$0.5m), Pūainuku Vines (\$0.9m), and Te Puia Tāpapa (\$0.9m).
- Horton Street developments are complete, now classified as commercial property, with Urban Winery as a key tenant receiving positive community feedback.
- Flaxmill Vineyard value declined by 16% due to industry challenges.
- A sub-committee of Trustees and Directors has been formed to determine the use of RNZAF Base Woodbourne redress funds.
- Wairau Development (Waikārapi): After delays due to government changes, the 94-section project is ready to proceed, with 40 sections for community and affordable housing prioritising iwi members. Construction tenders will be invitation-only, with work beginning in 2025.
- Housing cost models are still being finalised and will be communicated to iwi. Homes will range from 1 to 4 bedrooms, with some featuring carports or garages. Discussions are underway with the Council to extend the bus route.
- Whānau businesses will receive preference in the tender process. Employment opportunities, including apprenticeships, will be considered.
- Members requested that Rangitāne values and te reo Māori aspirations be reflected in the development. Trustee Judith MacDonald emphasised the goal of providing warm, dry homes, in a balanced approach.
- A member asked about investment in cultural products/tourism. Leigh confirmed that cultural strategy discussions are planned.
- Directors will focus on diversifying investments, including property development and diversified agriculture.

Te Tari (presented by Corey Hebbert)

- The meeting watched a video of highlights from the year.
- The General Manager acknowledged whānau who have passed during the year with special note to Uncle Taane MacDonald. He acknowledged the office team, whānau in the room and online, Kaikōkiri, Whakapapa Komiti, Marae Komiti and the work carried out by representatives on various Kōmiti and agencies. He also acknowledged Miriam Radich for legal work carried out over the year, particularly in relation to the East Coast Bylaw and whale jawbones matter.
- The General Manager provided an update on key projects including:
 - Blenheim Sewerage Treatment Plant Consent

- Protecting Rangitāne right and interests, regionally and nationally
- Rising Tides – Research Project with NIWA
- Te Pokohiwi o Kupe – Cultural Mapping and Values
- Te Pokohiwi o Kupe – Conservation Management Plan
- Aquaculture Settlement Reconciliation
- Digital Archives Project
- RNZAF Base Woodbourne
- An update was provided on the launch of Whānau Saver Savings Scheme which is a unique scheme with benefits for members. It is easy to sign up online and provides a practical way to build savings for now and future generations.
- Aunty Tui MacDonald asked whether her question raised at last year's AGM regarding SILNA lands had been actioned. The General Manager updated that he has raised this with Minister Paul Goldsmith, but he does not believe it will be a priority for this Government. He noted the recent appointment of James Meager as Minister for the South Island and indicated that an invitation will be extended from Te Waka a Māui Iwi Chairs Forum to meet, he will put this kaupapa on the register.

Opportunities and challenges (Presented by Janis de Thierry)

- Resourcing the Strategic Plan.
- Continued change to Government policy, particularly in light of the new Coalition Government.
- Availability, and sometimes lack of Rangitāne cultural practitioners residing in Te Tauihu. The Trust is looking at ways to increase this capacity i.e. working collectively with Kurahaupō iwi.
- Overlapping interests with other iwi. We will continue to vigorously oppose anything that encroaches on our customary rights and interests.

6. GENERAL BUSINESS

- A comment from whānau on the live stream acknowledged Corey Hebberd for his RMA Commissioner certification.
- Jeffrey Hynes acknowledged the Trustees and the legal team for their work on East Coast Bylaw. He asked if the Trust would consider naming the wharenui and wharekai at Tuamatene and suggested that cultural artwork is installed on the walls of Ūkaipō. He also noted his disappointment with the Woodbourne settlement. He suggested artwork inside the airport could be an idea for the future.
- Suggestion for a seed bank of heritage plants. The General Manager noted that he will take away this idea for further kōrero.
- A question from the live stream – are whitebait customary rights permits allowed outside of the usual period. The General Manager noted that the advice from DOC is that the regulations don't require a permit, but the best practice would be to contact iwi for a letter or permit.
- A question from the floor – how are we ensuring that we are looking after our sites of significance. Peter Meihana noted that the first step is to identify the sites, the more we know the better prepared we are to look after them. The General Manager noted that we are working with Marlborough District Council on their Environment Plan, i.e. the land between the Wairau River and the Diversion.
- A question from the floor – what are the Trust doing to grow the livelihood of our people and what are the tangible actions to give back to whānau. The General Manager advised that the

Trust is guided by the Strategic Plan and encouraged whānau to feedback on this, now is the time as the plan is up for review. He asked whānau to think about what they want the Trust to be focusing on.

Future Voting Process Update (presented by Corey Hebbard)

- Currently, voting packs are sent by post and email where possible. This election costs \$30k.
- In May 2024, Management proposed that, from 2026, voting papers would no longer be posted to members under 60 if we hold a current email address.
- This aligns with other Te Tauihu iwi and provides a \$9k saving. The Board approved this change for the 2026 elections.
- A campaign will be run later this year to encourage members to update their details.

7. TRUSTEE ELECTION RESULTS

Isiah Roberts of electionz.com declared the following result:

Two Ordinary Vacancies (3 Years)
