Financial Operation

Audit, Risk and Compliance Committee

As our financial year draws to a close, we move into audit season. A new Audit, Risk and Compliance Committee (ARCC) consisting of Trustee Leigh MacDonald, Independent Director Megan McKenna and led by new Independent Chairperson Dave Jessep has been appointed. Dave Jessep is born and bred in Blenheim and is managing director of his own accountancy firm in Christchurch. This committee will be ably supported by our accounts manager Diane Ryan and will work closely with our General Manager Nick Chin.

The ARCC had its first meeting in March and after a Request for Proposal process which included interviews, BDO have been appointed to provide audit services for the 2017-2018 financial year. This is a new working relationship with Mark Bewley and the BDO team in Wellington and we look forward to working together. This does however mean a departure from our long term relationship with Trevor Deed and his team at Deloitte.

We acknowledge and thank Deloitte for the many years they have served Rangitāne.

Accountancy Services

A Request for Proposal process for accountancy services will run after this year's full year accounts and audit processes have been completed.

Review of Settlement Structure and Transactions

As we indicated last year, an independent review has been undertaken to ensure we have met all our responsibilities under the Deed of Settlement and the Trust Deed.

The Trustees have applied to the High Court under the Trustees Act 1956 for directions on this matter so that we can all be assured everything is in order. We will communicate the results of that application as soon as we have them.

Great opportunity for young divers

In November last year our Mātauranga kete launched a pilot programme aimed at building a database of iwi divers who may be able to assist with customary dives by offering three PADI Open Water Diver scholarships.

Successful applicant Jasmine Luke tells us why she wanted to take up this opportunity and what she thought of the course. "My dad is a diver, when I was younger my mum wouldnt let me go diving, but now I'm older I can do what I want. I have been free diving for 2 years now so when the opportunity came up through Rangitāne o Wairau to apply for a scholarship to learn to scuba dive I thought why not, what have I got to lose.

I have thoroughly enjoyed learning to dive, there was quite a lot of reading to do, there's so much you need to know, it's not just a matter of jumping into the water.

Bryan from Blenheim Dive Centre is an amazing teacher, he teaches at the level the student is at, he's very patient.

Now that I have my ticket Im looking forward to contributing when it comes to occasions such as tangihanga, I'll be able to go out with the guys to gather kaimoana. I also want to share the knowledge and help others when they start out diving. Maybe dad might show me some of his secret spots."

Bryan says Jasmine is a natural in the water and says she is, "absolutely loving the opportunity to learn scuba diving."

Dylan McManaway and Nathan Thompson also received a scholarship, both are super keen to get back in the water with Bryan soon to complete the course.





Iwi and Māori Business Forum

In conjunction with Ngāti Rārua and Ngāti Toa Rangatira, we hosted the inaugural lwi and Māori Business Forum at Ūkaipō on 21 March.

With Trustee Jeremy MacLeod as Master of Ceremonies, it was a pleasure to listen to keynote speaker, the Honourable Nanaia Mahuta, Minister of Māori Development and Local Government. Nanaia challenged us to focus on our strengths, not on "deficit" thinking. She spoke about the coalition government wanting to reset relationships between the Crown, the Iwi Chairs' Forum and other Māori organisations. The Government are looking to do things differently with informed plans to work collaboratively on areas of strategic alignment.

Simon Phillips, NZ Māori Tourism's Director of

Regions, presented "Māori leading Aotearoa visitor experiences" which gave us a status update on Māori tourism in Aotearoa while highlighting the obvious opportunities we have here in Te Tau Ihu.

Dave Johnson, General Manager at Ngāti Kuia walked us through the bee husbandry initiative they have set up for whānau at Titiraukawa.

Paul Morgan of Wakatu Incorporated gave us food for thought when he spoke about shifting our focus from small individual iwi driven projects to macro projects involving many iwi across Te Tau Ihu.

Thanks to Lorraine Eade of Westpac for her leadership in coordinating the project and to the Rangitāne o Wairau staff and all those who contributed to the manaakitanga of the day.
